## **General Information Registration**

The Lake Shore Central Summer Driver Education program is open to students currently enrolled in the Class of 2018, Class of 2019 and Class of 2020. Students must have attained the age of sixteen (16) years by July 1<sup>st</sup>, 2018, and who hold a valid New York State Driver's permit or, a valid New York State Driver's license. **Registration must be done at the William T. Hoag Educational Center, between 8:00 am - 4:00 pm**. <u>The last date for regular registration is Thursday, May 17<sup>th</sup>, 2018</u>. Registration is open to all students with preference given to Lake Shore residents. Late registrations will be placed on a waiting list. Cell phones must be turned off and put away during class and driving sessions. *Proper footwear is expected*.

## Schedule

Classes will begin on Monday, July 9<sup>th</sup> at 7:30 a.m. and classes will continue until Thursday, August 2<sup>nd</sup>. All classes will be held at the Middle School. Your confirmation of assigned times for driving session and lecture class will be provided after the registration period ends.

## Attendance

In order to receive MV-285 certificates students must attend *every* driving session and *every* lecture class. Attendance is crucial. The DMV does not allow for make-up sessions.

## Length of Classes

Each session will be 90 minutes in length. Students must complete 24 hours of classroom instruction and 24 hours of experience in an automobile. Classes and Road Groups will be held Monday – Thursday between 7:30 a.m. and 3:20 p.m. The course will be 16 consecutive days as shown below. *Submission of the registration form with payment does not guarantee specific class times. You will receive confirmation of placement and class time.*

#### Fees

A \$375.00 fee will be charged and collected at the time the registration is submitted. <u>The registration fee of \$375.00 is not refundable after June 29<sup>th</sup>, 2018</u>. We accept cash, checks, money orders and credit cards (Master Card, Visa, Discover, American

Express). Please make checks or money orders payable to Lake Shore Central School District.

## **Course Credit**

High school credit cannot be awarded for completion of this course. An insurance reduction form will be issued to students who successfully complete the classroom portion of the program (65% final average) and the laboratory (automobile final average of 65%) portion of the program separately.

#### **Transportation**

There will be no transportation provided by the Lake Shore Central Schools to or from this program. Unlicensed vehicles (mopeds, dirt bikes, ATV's) may not be used to transport students to or from the Driver Education program.
