# Quality Education and Facilities are Essential

ach school year one of the top priorities of The proposed 2017-18 budget (Proposition 1) is ■ the Superintendent's office is to work closely with our Board of Education to develop a workable budget. Through days and even months of diligence, this group is charged with analyzing the needs of our classrooms, our buildings and grounds and our transportation fleet. At the same time, we are also spending many hours advocating for stronger State and Federal Aid, all to design a budget that supports the high-quality educational programs for our students.

The proposed budget will support our students' educational programs, fund state and federal education mandates and meet operating costs and contractual obligations for the coming school year.

In this edition of the Eagle Express you will find information about the proposed budget as well as information concerning a proposition for replacement vehicles to be added to our fleet. In addition, detailed information concerning two Capital Construction Project propositions has been included, both of which will also appear on this year's ballot.

All ballot line items are intended to provide proper funding for classroom equipment, updates in technology, and the retention of our course offerings including Advanced Placement Classes, to ensure we are preparing our students for college and careers.

You will also find profiles of two candidates running for positions on the Board of Education.

\$58,225,880, representing an increase in \$1,718,119, with an anticipated tax levy increase of 1.2%, or \$204,656. The proposed budget reflects NO change to the fund balance. This plan maintains the integrity of our overall instructional plan.

Proposition 2 authorizes the purchase of three 71-seat buses and two 30-seat buses at a total cost of \$486,885.20. This second proposition has **NO** impact on the proposed budget.

Capital Construction Project Part 1 (Proposition 3) includes high-priority facilities and program needs identified during the State-mandated building condition survey. Part 1 will have NO impact on the Local Tax Levy.


Capital Construction Project Part 2 (Proposition 4) includes additional improvements to the District's arts, athletic, music, and technology programs. Much of the cost is covered by State Building Aid and Debt Reserves, with the remainder to be paid by the Local Tax Levy. On an average assessed \$100,000 home, Part 2 will have an average estimated Tax Levy of 1.07%, or \$18.98.



# Lake Shore Budget Facts

- ♦ The current 2016-17 budget is \$56,507,716. The proposed 2017-18 budget is \$58,225,880, representing an increase \$1,718,119 or 3.04% over the 2016-17 budget.
- ♦ The District has received the highest designation possible from the New York State Education Department. Lake Shore is designated as a "District in Good Standing." This ranking is based on academic performance and established criteria in the New York State Report Card.
- **♦** The proposed budget does not change the fund balance.
- ♦ Our tax increase is 1.2% representing in a property tax increase of \$204,656. Our tax cap is 5.06%.
- ♦ Proposition 2 will authorize the purchase of five buses with no impact to the 2017-18 budget.
- ♦ The proposed 2016-17 budget is balanced through:

#### **Proposition 1: 2017-18 Budget**

RESOLVED, that the budget for the Evans-Brant (Lake Shore) Central School District for the fiscal year commencing July 1, 2017, and ending June 30, 2018, as presented by the Board of Education, is hereby approved and adopted and the required funds therefore are hereby appropriated and the necessary real property taxes required shall be raised by a tax on the taxable property in the District to be levied and collected as required by law.

#### **Proposition 2: Vehicle Purchase**

**RESOLVED,** that the Board of Education of the Evans-Brant (Lake Shore) Central School District (the "District) is hereby authorized to **purchase the following replacement vehicles** for use by the District in the transportation of students and general use by the District: three (3) full size diesel-powered 71-passenger school buses at an estimated maximum cost of \$120,885.38 each; two (2) 30-passenger gasoline-powered school buses at an estimated cost of \$62,114.53 each; for a total aggregate maximum cost of \$486,885.20; with such aggregate cost to be raised by a tax upon the taxable property of the District to be levied and collected in annual installments as provided in Section 416 of the Education Law, with such tax to be partially offset by State aid available therefore, and, in anticipation of such tax, by the issuance of debt obligations of the District as may be necessary, not to exceed such maximum aggregate cost. No tax levy increase is anticipated for this proposition.

#### **Proposition 3: Capital Construction Project Part 1**

RESOLVED that the Board of Education of the Evans-Brant (Lake Shore) Central School District, Erie County, New York is hereby authorized to undertake a District-wide capital improvement project consisting of: (A) the construction of alterations, renovations and improvements to the District's existing buildings and facilities, including in each case, as needed (i) renovations, alterations and improvements to classrooms, hallways, offices, cafeterias, gymnasiums, locker rooms, and pool areas, (ii) renovations to school offices including security-related initiatives, (iii) refinishing of floors and walls, (iv) reconstruction and/or replacement of roofs, (v) replacement of and/or improvements to mechanical, electrical, lighting, plumbing, hot water, fire alarm, and heating, ventilation and air conditioning fixtures and systems, (vi) reconstruction of and/or improvements to exterior walls, concrete foundation surfaces, chimneys and expansion joints, and (vii) replacement of exterior doors, frames and hardware and of windows; (B) the construction of additions to each of the Lake Shore Senior High School and the Lake Shore Middle School to include unisex toilet rooms, and other appurtenant and related improvements; (C) renovations, alterations and improvements to the Transportation Center; (D) site work improvements including construction, reconstruction or replacement of parking areas, roadways, sidewalks, curbs, water mains, storm water and drainage improvements, exterior security lighting and landscaping; (E) the acquisition and installation in and around the foregoing improvements of original furnishings, equipment, machinery, and apparatus; and (F) all appurtenant, related and incidental improvements, costs and services to the foregoing; all at a total estimated maximum cost not to exceed \$43,350,095, with such cost being raised by a tax upon the taxable property of the District to be levied and collected in annual installments as provided in Section 416 of the Education Law, with such tax to be offset by State aid available therefore, and in anticipation of such tax, by obligations of the District as may be necessary. No tax levy increase is anticipated for this proposition.

#### Proposition 4: Capital Construction Project Part 2

**RESOLVED** that, in the event that Proposition No. 3 is approved by a majority of the qualified voters of said District voting thereon, the Board of Education of the Evans-Brant (Lake Shore) Central School District, Erie County, New York is hereby further authorized to undertake the following additional capital improvements: (A) at the Lake Shore Senior High School, refurbishing of existing tennis courts, additional fencing at the baseball field and replacement of the softball field backstops; improvements to the gymnasium including but not limited to replacement of bleachers, renovations and improvements to track flooring and replacement of dividing curtain; alterations, renovations and improvements to the auditorium, orchestra room, and projection room, and the renovation of music classrooms; construction of a new concession building to replace the existing concession stand; and the construction of additions and alterations to accommodate an athletic entrance area, locker rooms, a weight room, a trainer room, an athletic office, a multipurpose instructional classroom, a technology classroom, renovated music classrooms and an exterior entrance to the stadium; (B) at the Lake Shore Middle School, improvements to the gymnasium, including but not limited to replacement of flooring, bleachers and backstops, and painting; and alterations, renovations and improvements to the auditorium and orchestra room; (C) at the Anthony J. Schmidt Elementary School, renovations of the former locker room into a teaching station, renovations of classroom toilet rooms, and refinishing of the auditorium stage floor; (D) at the Highland Elementary School, replacement of playgrounds and improvements to outdoor basketball courts; (E) at the John T. Waugh Elementary School, installation of improved climate control equipment in second floor classrooms; (F) the acquisition and installation in and around the foregoing improvements of original furnishings, equipment, machinery, and apparatus; and (G) all appurtenant, related and incidental improvements, costs and services to the foregoing; all at a total estimated maximum cost not to exceed \$16,496,730, with such cost being raised by a tax upon the taxable property of the District to be levied and collected in annual installments as provided in Section 416 of the Education Law, with such tax to be offset by State aid available therefore, and in anticipation of such tax, by obligations of the District as may be necessary.

# "MEET THE CANDIDATES - BUDGET AND CAPTIAL CONSTRUCTION PROJECT HEARING NIGHT" Tuesday, May 9

Meet the Candidates - Budget and Capital Construction Hearing Night is scheduled for Tuesday, May 9 at 6 p.m. and 7 p.m. respectively in the Lake Shore Senior High School Media Center. There are two (2) Board of Education candidates seeking two seats on the Board of Education. At 6 p.m. each candidate will be introduced to the public. They will then present their platform for becoming a candidate for the Board. The floor will then be open to the public for questions to individual candidates. If there are no questions from the floor and/or if time remains, there will be a casual meet and greet with the candidates. At 7 p.m. the Budget and Capital Construction Project Hearing will begin. The Assistant Superintendent for Administration and Finance and Superintendent of Schools will then present an overview of the District's proposed 2017-18 Budget, followed by a question and answer period.

#### Dear Community Members,

On May 16, 2017, residents of Lake Shore Central School District will have an opportunity to vote on a Capital Construction Project that is designed to address critical facilities needs in each of our buildings; vehicle and pedestrian safety outside our buildings; and academic improvements for students throughout our District. The project is based on the needs assessment required by the State Education Department every five years to be sure we are planning for and maintaining the District's assets.

The Capital Construction Project proposition was achieved through the planning and collaboration of our Facilities Committee (comprised of District Administration, Board of Education members and our professional services team), along with input from various District residents.

During the planning process, the Committee identified over \$90 million in potential facilities, site and educational needs. After further review and prioritization, the Committee recommended a financially prudent Capital Construction Project that would maximize our available State Aid and minimize the impact to taxpayers, while addressing the most critical and beneficial needs — key objectives set by the Board of Education.

The result is the two-part Capital Construction Project proposition that is explained further within this newsletter.

Over the years, we've experienced the pride and involvement the Lake Shore community has in our District. Capital Construction Projects like these not only help to keep our facilities in good working order, but also to improve the conditions under which our children learn and thrive. Through careful financial and educational planning, we are confident we will continue to be one of the region's premier school districts.

We strongly encourage you to learn more of the details of this exciting project on our website and by attending the District's Public Hearing on Tuesday, May 9 in the Senior High Media Center.







### Frequently Asked Questions

#### Q. Why is the District having a Capital Construction Project vote?

**A.** Our District is committed to providing a safe learning environment and well-maintained facilities for students and public use. Routine facility maintenance and repair work is typically funded within the annual District budget, with local taxpayers bearing the full cost. However, large renovations, repairs and replacement of "end of useful life" items, such as those included in this project, would have a major impact on the tax rate if included in the annual District budget. A Capital Construction Project bond issue is the fiscally responsible alternative because the State reimburses much of the cost, and the expense is spread out over a longer period of time.

#### Q. How were the project's components chosen?

**A.** Every five years, all school districts are required by the State to have a certified Architect review the condition of their buildings and grounds. In 2015, our architectural consultant performed a Building Condition Survey (BCS) that examined the District's facilities and identified problem areas requiring repair or replacement. A District subcommittee studied the BCS items and developed a prioritized list of recommended repairs and upgrades. The District is addressing those issues now, rather than delaying and facing future higher costs and further deterioration. Building Condition Survey items, academic program enhancements and safety concerns received top priority, as did code compliance, mechanical systems and building envelope items.

#### Q. What is the total cost of this proposed project and how will it affect my taxes?

**A.** The total combined cost of Capital Construction Project Parts 1 and 2 is \$59,846,825:

Capital Construction Project Part 1: \$43,350,095 (**ZERO** tax increase)
Capital Construction Project Part 2: \$16,496,730 (1.07% tax increase)

All of the work included in Part 1 will be paid for using a combination of State Aid funding and the District's expiring debt. There will be no impact to your taxes based on Part 1. State Aid will also cover much of the cost of Part 2, with the remainder to be paid for through the local tax levy. On average, a homeowner with a \$100,000 full/equalized home value can expect an estimated annual tax increase of 1.07% — about \$18.98 per year — before exemptions such as STAR savings. Capital Construction Project Part 2 can only pass if Part 1 is also approved.

#### Q. Isn't State Aid just my tax dollars too?

**A.** Yes, it is. The New York State Education Department budget and State Legislature has given all Districts in the state an opportunity to use tax dollars to enhance their communities through school building improvements and renovations. By taking advantage of this opportunity, we can reinvest some of those tax dollars back into our district to improve the educational setting for our children and the community.

#### Q. Can we just vote to do Part 2?

**A.** No. Capital Construction Project Part 1 must pass in order to enact Capital Construction Project Part 2.

#### Frequently Asked Questions (continued)

#### Q. What if either Part 1 or Part 2 does not pass?

**A.** If either or both parts of the Capital Construction Project don't pass, the critical building safety components of the project will still have to be addressed as required by the State. The taxpayers would then be responsible for the expenses through the annual budget and tax levy, but without the benefit of State Aid.


#### Q. When will the work begin?

**A.** Following the design process, the project then goes to the NYS Education Department for review and approval. It is currently anticipated that contractor bidding will be in late 2018 or early 2019 with construction beginning in 2019.

#### Q. Where can I find more about the Capital Construction Project propositions?

**A.** A Public Hearing will be held on Tuesday, May 9 at 7:00 p.m. in the Senior High Media Center. That hearing will include an open forum for questions and answers regarding the Capital Construction Project, the annual budget and our school board candidates.
