ADDICTION RESOURCES IN YOUR SCHOOL AND COMMUNITY SUBSTANCE USE RELATED SERVICES

Confidential Information Available For Students, Parents, and Staff

McKinney's Education Law §3038 requires the superintendent of each school district, in consultation with the local Board of Cooperative Educational Services (BOCES) District Superintendent (DS) where applicable, to designate an employee of the school district or BOCES to provide materials and/or resources upon request to any student, parent or staff regarding where and how to find available substance use related services. Where possible, the designated employee should be a school social worker, school counselor, or any other health practitioner (i.e., school psychologist, school nurse). The request for and the provision of substance use information to a student, parent or staff shall be confidential, may not be used in school disciplinary proceedings, and as related to other applicable privilege, remain confidential pursuant to section § 4508 of the Civil Practice Law and Rules. However, there is nothing in the new law which relieves a designated employee of their legal duty to otherwise report information.

McKinney's Mental Hygiene Law §19.07 assists schools in meeting the requirement & requires the New York State Office of Alcoholism & Substance Abuse Services (OASAS), as the subject matter experts, to consult with NYSED to provide substance use educational materials. Materials will be age-appropriate and

include information or resources for parents to identify the warning signs and address the risks of substance use with their children. Topics include misuse and abuse of alcohol, tobacco, prescription medication & other drugs with focus on substances prevalent among school aged youth.
