Dear Parents / Guardians:

Welcome to the 2020- 2021 school year! It's hard to believe that we are already sending out Progress Reports for the 1<sup>st</sup> quarter.

As you are aware, our platform for education is vastly different than years past. We wish we could see all our students everyday but with the NYSDOH guidelines for COVID-19 that is not an option for us at this time.

Over the summer we had the opportunity to reconfigure how we would move our students forward academically and our students seem to be adapting well. Although we continue to refine the process I want to share some ways that you as parents/guardians can assist:

- 1) Students are assigned work that covers 5 days of material. For each student that may look slightly different based on your personal decisions to have your child attend school in person vs. remaining 100% remote. It is imperative that your child work on their academics daily.
- 2) Our students will receive numerical grades for their work. Timely completion of assigned material will be their best way of staying on top of the assigned work.
- 3) Check Power School weekly to view your child's academic progress.
- 4) Teachers are available for questions daily and students have been given teacher information so that they can reach them when not in the building. That can be by phone, by email, through Remind, or on a Google Meet. Please encourage your child to reach out to their teacher if they need help.
- 5) Your child's counselor is available to answer questions or provide support if needed. Student's can identify their counselor by looking at their schedule. The breakdown by alphabet can also be found on the high school home page.
