- 1. Lake Shore Sr. High School Discussion with Julie Hoerner Ms. Hoerner shared with the Board that this year they began providing reading services to high school students this year in an AIS lab. Services will continue next year and will target students in grades 10, 11 & 12. The focus of faculty meetings, Student Government & the Leadership class have been to engage both students and faculty in activities to foster a positive climate. The National Honor Society will induct 49 students this year, the highest number of students in many years, several students have been recognized in local papers for art work, photography and literature pieces. Mr. Fisher and the school counselors are working diligently to contact parents and students regarding attendance issues. Letters are sent out requesting meeting with care providers every 5 weeks. We have incorporated the SRO into this process to help facilitate getting students in school. The success rate has been minimal as parent response/participation has been limited at best.
- 2. 2015-16 Budget Discussion Mr. Pacos provided the Board with a detailed overview of the 2015-16 budget. The District was able to balance the budget without making further cuts, keep our proposed tax levy under the cap and qualify for the tax rebate, and reduce our appropriation of fund balance by another million dollars from \$3.5 million down to \$2.5 million.
