IV. Discussion

1. A. J. Schmidt Elementary School – Discussion with Susan Ciminelli – Mrs. Ciminelli gave a brief overview of her second year at A. J. Schmidt Elementary. She indicated this year's open house had a record number of parents attending. There were 88 students that participated in the summer reading program. They currently have 52 PTA members at A. J. Schmidt. The student retreat theme for grades 2 & 3 was "Be a Hero to yourself." The theme for Grades 4 & 5 was "To be a Knight", what it means to be a knight and what kind of character is needed to be a knight. Report cards were shared with students to show them how to read a report card and what everything means. They also included the state assessment scores on the report cards for kids to see how they did on the assessments. Currently staff at A. J. Schmidt is focusing on Common Core and the changes in RtI. They are currently working with the Town of Evans to help facilitate the Safe Routes to School grant application by providing the Town with letters of support from parents, community members, and the District in favor of the program.

2. Summer School Reports – Melissa Evingham – Ms. Evingham provided the Board with a brief summary of the 2012 Summer School Program.
